Director's Report Highlights:

- All staff meeting 17 December 2002: going over collection challenges
- Eric completed his public library director certification with DPI
- Circulation: moving some collections around to make more room for additions.
- Foot traffic is about 19% higher than in 2021 and 70% of our foot traffic during prepandemic years.
- ½ of library revenue comes from Jefferson Co. Board of Supervisors.
- Nalox ZONE box I have started working with UW-Madison and their agency called 'Wisconsin Voices of Recovery' to install two Narcan dispensing boxes in the ground floor restroom. They will provide Narcan and refill these boxes over the course of time.
- Patrons Banned from the library In two separate instances in Nov. 2022, I banned three individuals from future use of the library building. In one instance, an individual was banned for violating portions of our Code of Conduct. These violations were: Loitering,

Producing excessive noise separate from an authorized Library program, Adult use of juvenile and teen areas, Disorderly, drunken, dangerous, disruptive, or threatening behavior that may jeopardize the personal safety of patrons, staff or facilities at the Library. In the second incident, a couple was banned for the following Code of Conduct violations: Loitering, Disorderly, drunken, dangerous, disruptive, or threatening behavior that may jeopardize the personal safety of patrons, staff or facilities at the Library, Consumption of intoxicants, tobacco, and food.
