Friends of Lorine Niedecker (Discussion - Ann Engelman & Amy Lutzke):

- Amy Lutzke will be stepping down from her position on the Friends of Lorine Niedecker

 the Friends of Lorine Niedecker are a support organization and will support the library
 as the steward of the Niedecker collection and make recommendations/suggestions. The
 Friends is a 501c3 organization that pays for things related to the collection and
 Niedecker research that is outside of the Library's mission.
- She wants to ensure the Library Board understands the Niedecker collection
 - Significance: Niedecker's books (notes, etc) that she directed be given to the library
 - Niedecker directed her husband to burn all her journals, so the books she donated to the library are really the few remaining sources for researchers.
 - Hoard Museum also has Niedecker archives: photos, paintings, ephemera
- In next year, the Friends of Lorine Diedecker, Library Director and staff, and Library Board will work together to maintain the collection and researcher access.

- Summer Reading Program was very successful. Minetta did an outstanding job, as usual!
- Patron traffic In June and July 2023, our foot traffic (6,776 and 6,092) was 9% and 2% higher than in June and July 2022 (6,294 and 5,972).
- Discovery Layer (for catalog) The Bridges Library System library directors have voted to move forward with a discovery layer for the catalog. The next step(s) are to go to RFP for vendors to see if we can find the feature set and cost that is acceptable to the library system and individuals libraries.

Strategic Planning update – Eric R. (Discussion):

- Categories: Staff, Space, Programs, Innovation
- Providing a guiding framework for the limited resources available.
- Library staff will have a Saturday staff meeting next week that will focus on Strategic Plan.

Library Budget (2024) update – Eric R. (Discussion):

- Circulation is up for non-county residents and residents in communities within Jefferson Co. that do not have libraries. This means more revenue coming in from the state to offset these costs.
- Finance committee will meet soon and discuss the budget and the parameters of using the trust.
